

Mountaineer's Day Festival / Hero's Day

Vendor Rules and Application

2nd. Week-End in September, 2012

1. Absolutely NO alcohol, firearms, or drugs permitted.
2. All vendors need to submit clear photos of their work.
3. All vendors selling wares/food will be responsible for collecting Tennessee State Sales Tax.
4. Booths may be sub-let. All vendors' names and products must be submitted at application time. After approval, no sub-letting will be permitted or non-approved items sold.
5. Crafts must be hand made, but can be from kits.
6. Food vendors must call in advance. We try to have a variety of foods and limit the amount of vendors selling the same food items.
7. Food vendors must be aware of, and follow, the state's laws, rules, fees, and regulations that pertain to servicing, preparing, and distribution of food materials. Official state inspections may happen any time during the event. Failure to follow regulations will result in the shut down of your food services. No refunds will be given in the event that your food services are closed down by government officials.
8. The committee reserves the right to request removal of non-complying or offensive objects.
9. No criticizing of other vendor's products to customers or other vendors.
10. If for some reason an exhibitor cannot attend, the committee must be notified, in writing or by telephone, within two weeks of date of show, for reimbursement of booth fee. No Refunds will Be Made After Cut-Off Period.
11. Demonstrations are welcome during the fair, however electricity is limited. You may use lanterns, generators, or propane; you are required to bring 100 foot extension cord to use with generators.
12. This is an outdoor fair and exhibitors are responsible for their own chairs, tables, display material, and protective coverings, as the fair will be held rain or shine.
13. Vendors must clean up site when finished or will be fined a \$25.00 fee.
14. There will be awards given to the top three booths expressing the theme of the festival (Mountaineer Days); therefore, period clothing (pre-electric) is encouraged, if possible.
15. Each exhibitor is responsible for the safety of his/her own display. It is understood that neither the committee nor Tracy City will be held liable for damage, theft, or loss of exhibitor's work, display materials, or personal property, nor for injury of exhibitor, or loss or injury caused by products, sold or exhibited, by participants of

the fair, directly or through warranty expressed or implied. Insurance of such loss, damage, or injury shall be sole responsibility of the exhibitor at their own cost. Your signature on the entry form indicates an agreement to hereby and forever discharge the above named from such matters of action, suits, damages, claims, and demands whatsoever in law or equity from loss or damage to the signer's property while involved in the fair.

16. If the rules above are not followed, the committee reserves the right to ask you to leave, at which time no refund will be given.
17. The term "committee" used in this application refers to the members of The Mountain Heritage Preservation Society and members of the Mountaineer's Day Festival and staff.
18. All of the above rules apply for both events.
